OFFICE MEMORANDUM

On the recommendations of the Selection Committee met on 28.05.2022 constituted for the selection of Intern, the Director, ICAR-Central Soil Salinity Research Institute, Karnal is pleased to offer an assignment of Intern to Ms. Anshul Phogat D/o Sh. Dharampal in "Development of Arbuseular Mycorrhizal Fungi(AMF) based plant biostimulant to enhance the productivity of salt affected soils" for the period upto March, 2025 or co-terminus of the project, whichever is earlier on the following terms and conditions and other rules issued by the Govt. of India/ICAR/DST-SERB from time to time: -

1. She will be allowed a fixed salary of 20,000/- Plus HRA(Rs. Twenty thousand only).
2. The assignment can also be terminated by the Director of the Institute without notice at any time without assigning any reason thereof
3. The post is purely temporary and will be terminated as and when project terminates.
4. She will have no claim for any regular or permanent appointment in this Institute/ ICAR/DST-SERB as it is purely temporary time bound arrangement on co-terminus basis with the project.
5. Her fellowship will be terminated on completion of her terms of appointment or on the date given in the sanction of the project, whichever is earlier.
6. If she leaves her assignment without prior permission of this Institute, she shall not be paid any fellowship amount due to her, but not paid to her by the Institute.
7. She will work under the immediate administrative control of the PI, but overall control of the Director, CSSRI, Karnal
8. She can also request for her termination before the expiry of the project by giving one month's notice in writing and with the approval of the Appointing Authority.

If the assignment is acceptable to her on the terms and conditions mentioned above, she should report to the Director, ICAR-CSSRI, Karnal for duty within a period of 15 days from issue of this memorandum, failing which, the offer will stand cancelled automatically. Her joining will be subject to submission of Medical Fitness Certificate from district CMO/Civil Surgeon and character certificates from two gazette officers.
