- **TERM & CONDITION** 1. The envelope containing tender and other documents should be clearly written the name of the work, Reference no. closing date failing which the tender will be returned without opening.
- 2. The contractor should mention the correct postal address and contact no. The contractor should inform to the office in writing immediately about any change. Institute shall not be responsible for non - receipt of document due to postal delay/ undelivered/ non- recipient at your end.
- 3. The item wise rate may be quoted on the printed letter pad of the firm (If inspection of site and clarification in respect of the detail of the tender document can be sought from
- 4. Work shall be carried out as per the instruction, direction and satisfaction of OIC Estate CSSRI,
- 5. The rate should include all labour and materials charges, transportation, tool and tackles etc. as required for completing the work.
- 6. The work should be started within 5 days from the date of issue of work order and phonic message failing which the performance security to be forfeited on the recommendation of the OIC Estate.
- 7. The Director shall have the liberty to postpone or not to execute any item of work and the contractor shall not be entitled to any compensation for non execution of such items of work.
- 8. All the material purchased for construction/ painting by the contractor shall be as per the CPWD/ISI/BIS standards/specification and got approved by the OIC, Estate, CSSRI, Karnal. The inferior quality or rejected material is to be removed immediately from the site failing which the same will get removed by the Institute and expenses involved will be deducted from the
- 9. The contractor should submit the detail of the measurement in A4 size paper (typed) standard format for the items of work executed under the agreement after completion of work duly signed and verification of the OIC, Estate, CSSRI, Karnal.
- 10. The water/Electricity as required for construction, curing & painting at site (if not available) shall be by the contractor for which no extra payment shall be made.
- 11. The store will not be provided to contractor for storing of the construction material & their tools.
- 12. In case of dis-satisfactory work the contract may be terminated at any time and in such case the performance security deposited shall be forfeited.
- 13. In case the contractor fail to work within the stipulated/ extended period of time and according to our satisfaction, the Director, CSSRI shall have right to terminate the contract and get the work through any Other firm or agency. In such case, the performance security of the contractor shall be forfeited.

- 14. Quantity of work may be increased or decreased according to the actual need of work and hence, minor deviation of work shall be undertaken as per quoted rate without asking any compensation.
- 15. The contractor has to deposit Security Deposit @ 5% of the total estimated cost through D.D./ Bank Guarantee for the period of contract towards proper performance of the contract within 15 days of issue communication letter for acceptance of rates by the Institute which shall be released after one year of successful completion of completed works.

16. The contractor has to pay minimum wage as per the rate of government instructions time to time to their labors force engaged for the civil work.

- 17. All other liabilities including taxes such as Income Tax and other taxes, labour cess, sale tax/Vat. service tax, ESI/EPF etc. imposed by the government from time to time shall be deducted from the
- 18. The tenderer should quote total amount after adding all the sub head in case total amount is not given in the quotation the tender shall be treated as in-complete and to be rejected.

19. After completion of the work, the left over material at the site, if any, shall be removed and site should be cleaned within 7 days.

- 20. The Director, CSSRI, Karnal reserves the right to accept or reject any or all the quotation/ tenders without assigning any reason there of and the decision of the Director, CSSRI, shall be final and binding to all concerned parties.
- 21. The Director, CSSRI, Karnal also reserve the right to cancel the work, after award of work due to any administrative/ technical reason.
- 22. The Director, CSSRI, Karnal shall be the sole arbitrator for all disputes between contractor and the Institute. The decision of Director shall be final and binding to both the parties.

23. Any type of official implements and help will not be provided by the office.

- 24. All precautionary safety measure have to be followed and risk if any, is to be borne by the contractor. Office will not be responsible for any miss-happening, if caused, during the execution of work to the contractor or his worker.
- 25. The Demand draft /banker performance security of EMD should be prepared for the work in favour of Director ICAR-CSSRI, Karnal.
