1. Presently, the engagement shall be for a period upto March, 2026, from the date of his/her joining, extendable on the basis of his/her performance and willingness of the PI to continue his/her further.
2. His/her engagement shall be guided by ICAR F.No. Agril.Edn.16/27/2014-HRD dated 30.07.2019 & 15.10.2024 and further guidelines issued by the Council/ GOI, in this regard.
3. He/She shall be paid a monthly consolidated salary of **Rs. 37,000/-p.m. + HRA (Rupees Thirty seven Thousand + HRA only) for 1st and 2nd year and Rs.42000/- p.m. + HRA (Rupees forty two thousand +HRA for third year)** .
