**OFFICE MEMORANDUM**

On the recommendation of the Selection Committee constituted for the selection of a Young Professional-I under the project entitle “ Intervention of Improved Agricultural Technologies for Transforming Agriculture for Enhancing Farmer’s Income in Uttar Pradesh” At CSSRI, RRS, Lucknow. The Director, ICAR-Central Soil Salinity Research Institute, Karnal is pleased to offer an assignment of Young Professional-I to **Mr. Ashish Shukla S/o Sri Kamlesh Chandra** for a period of up to One year (Extendable for 2 more year) or co-terminus of the project, whichever is earlier on the following terms and condition and the rules issued by the Govt.of India/ICAR from time to time:-

1. He/She will be allowed a fixed salary of Rs.30000/- per month (Rs.Thirty thousand only).
2. The assignment can also be terminated by the director of the institute without notice at any time without assigning any reason thereof.
3. The position is purely temporary and will be terminated as and when project terminates.
4. He/She will have no claim for any regular or permanent appointment in this institute/ICAR as it is purely temporary time-bound arrangement on a co-terminus basis with the project.
5. His/her fellowship will be terminated on completion of his/her terms of appointment or on the date given in the sanction of the project, whichever is earlier.
6. If he/she leaves his/her assignment without prior permission of the institute, he/she shall not be paid any fellowship amount due to his/her by the institute.
7. He/She will under the immediate administrative control of PI of the project but overall control of the Director, ICAR-CSSRI, Karnal.
8. He/She can also request for his/her termination before the expiry of the project by giving one month's notice in writing and with the approval of the Appointing Authority.

If the assignment is acceptable to him/her on the terms and conditions mentioned above, he/she should report to the Head, RRS Lucknow for duty within a period of 15 days from issue of this office memorandum, failing which, the offer will stand cancelled automatically. His/her joining will be subjected to submission of **Medical Fitness Certificate from district CMO/Civil Surgeon and character certificates from two gazette officers.**
