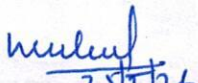

Eligible applicants may send their applications through proper channel in the enclosed proforma (as Annexure-A) in duplicate to the undersigned. **The last date of receipt of applications is 30.06.2026.** Applications received after the last date or otherwise incomplete including advance copies of the application are not likely to be considered. The Director, ICAR-CSSRI, Karnal, however, will reserve the right to accept/reject the applications without assigning reasons thereof.
3. The Director, ICAR-CSSRI, Karnal reserves the right to reduce/increase the number of posts at any point of time.
4. In case, applications are received in large numbers, criteria as prescribed by ICAR shall be applied and/or any other criteria formulated by the Selection Committee of ICAR-CSSRI, Karnal (in case of transfer sought on the same ground) for selecting the candidate for the above vacancies.
5. Terms & Conditions for Inter-Institutional transfer shall be governed as laid down in the ICAR's/ DOPT Guidelines.
6. It is requested that the above vacancies may be circulated widely and the applications of willing candidates having completed requisite service on the crucial date of eligibility and who can be relieved immediately in the event of their selection may be forwarded.
