- 1. After receiving performance security your EMD will be refunded as per terms & conditions of the contract.
- Before executing the order you have to submit the above as stated in Sr. No.1 within 15 days from the receipt of this supply order failing which, without any specific reasons the supply order will be treated as cancelled and your EMD will be forfeited.
- 3. The payment of the bill will release only after satisfactorily installation of equipments at CSSRI, Karnal and completion of all contractual obligations as mentioned above.
- 4. Delivery & installation on or before 28.03.2020.
- 5. Warranty: 01 year from the date of installation and commissioning of the entire system.
- 6. Billing: in favour of ICAR UNIT, CSSRI, Karnal.
