

OFFICE MEMORANDUM

On the recommendations of the Selection Committee constituted for the selection of Young Professional-I for Central Store, interview held on 09.07.2021, the Director, ICAR-CSSRI, Karnal is pleased to offer appointment of Young Professional-I purely on contract basis to Smt. Pushpinder Kaur in Central Store for a period of One year on the following terms & conditions and rules issued by ICAR vide F. No.Agril.Edn.1-06/2020-A&P dated 04.12.2020:-

1. She will be allowed a fixed salary of Rs. 25,000/- (Rs. Twenty five thousand only) per month as per guidelines of ICAR vide ICAR vide F. No.Agril.Edn.1-06/2020-A&P dated 04.12.2020. No House Rent Allowance (HRA) will be paid.
2. The assignment can also be terminated by the Director of the Institute without notice at any time without assigning any reason thereof.
3. The position is purely temporary and will be terminated as and when needed.
4. She will have no claim for any regular or permanent appointment in this Institute/ICAR as it is purely temporary time bound arrangement.
5. She will work under the immediate administrative control of OIC, Store, but over all control of the Director, ICAR-CSSRI, Karnal.
6. She can also request for her termination giving one month's notice in writing and with the approval of the appointing Authority.
7. The Young Professional will be entitled to avail Institute facilities like transport/canteen/dispensary/ library etc.
8. The working hours for the Young Professional-I will be same as regular employees of ICAR. No extra benefit will be allowed for working beyond office hours. Unauthorized absence from the work for a continuous period of 08 days without valid reasons shall lead to automatic termination of the engagement.
9. During the term of engagement she shall comply with the Standards of Conduct. Failure to comply with the same will become a ground for termination of the YP without notice.

If the assignment is acceptable to her on the terms and conditions mentioned above and regulations issued by ICAR office memorandum F.No.Agril.Edn.1-06/2020-A&P dated 04.12.2020, she should report to the Director, ICAR-CSSRI, Karnal for duty within a period of 15 days from the issue of this memorandum failing which, the offer will stand cancelled automatically. Her joining will be subject to submission of character certificates from two gazette officers and Medical cum fitness certificate from CMO.
